





For New Users


1. Go to https://www.citiprogram.org/ and create an account.



2. Select **National Healthcare Group – Singapore** as your organization affiliation.




3. Complete the required information as requested and continue all the way till **step 7**.




4. There will be four questions displayed at **step 7**.


